# 1.3. Additions/Amendments to and Approval of Minutes - 19 March 2013

#### - Funding and Application Guidelines Form

After the Annual General Assembly meeting, the Board was made aware of a misconception in our Funding and Application Guidelines as regards the description of a small ASBL by the Moniteur Belge, which should read as follows:

"A small ASBL is described as having a maximum revenue of €12.500 and a maximum equity of €1.249.500.

The Board apologizes that the amounts voted upon at the General Assembly meeting did not include the price-index adjustment of the above-mentioned revenue and equity, effective January 1<sup>st</sup>, 2013.

A motion was made and seconded to amend the future "Funding Application and Guidelines" form to depict the above amounts. The resulting vote was unanimous.

# - Internal Regulations

After the Annual General Assembly meeting, the Board was made aware of an inconsistency in Article 8 of our Internal Regulations regarding the number of charity projects allowed per country in relation to Belgium:

Last year the members incorporated a limit of two (2) International charity projects per country to be pre-selected by the Board. A proposal was made and seconded to retain this limitation. The resulting vote was 27 for and three (3) opposed. The limitation will be retained. For the sake of clarity, this limitation applies ONLY to the pre-selection of projects from International charity applicants. It does not apply to Belgian-based charity applicants.

A motion was made and seconded to amend Article 8 of our Internal Regulations to include the above clarifications. The resulting vote was unanimous.

### - Statutes

After the Annual General Assembly meeting, the Board was made aware of an inconsistency in our physical address at NATO (Brussels) and our registered address, which was changed to our new President's address in Tervuren (Flanders). The Moniteur Belge informed us that it is not allowed to have one address in Brussels and one in Flanders. Therefore, the following change in the Statutes was proposed:

#### "Article 3 - Registered Office of the Association

The decision to change the registered address of the Association may only take place at the General Meeting when the members are assembled. The decision to change the registered address of the Association may only take place at the General Assembly meeting when the members are assembled. The address of the Registered Office of the Association shall be the address of the President or the Vice-President. The Association is officially located at Avenue Victor Gilsoul 1, 1200 Woluwé-Saint-Lambert, in the judicial district of Brussels."

A motion was made and seconded to amend Article 3 of our Statutes to include the above addition/changes. The resulting vote was unanimous.

A motion was made and seconded to approve the amended minutes of March 19<sup>th</sup>, 2013 as depicted above. The resulting vote was unanimous. The amended minutes will be placed in the "Members Only" section of our web-site as soon as possible.

# 2. Bazaar Update – Jette Holm Kristensen (VP / Bazaar Coordinator / Web Designer) / coordinator@natocharitybazaar.org

#### 2.1. Preliminary Instructions

Following a short introduction, Jette went through the Preliminary Instructions for preparing for the Bazaar. She encouraged all of the members to read these instructions carefully. They can be found in the "Members Only" section of our web-site and contain suggestions for organizing the national teams, for getting Sponsors and for how to plan your national stand.

#### 2.2. Participation Questionnaire

Jette explained to the members that the Participation Questionnaire has been changed to make it easier to understand and to fill out. It can be accessed from the "Members Only" section of our web-site, downloaded, filled out electronically, saved and attached to an e-mail to her – or it can be printed, filled in by hand and turned in no later than the June  $25^{\text{th}}$  GA meeting. Carla introduced herself and her assistant, Sarah Kibble Bonifazi, who was unable to attend the meeting. She told the members that they are both looking forward to working with them and that she will have more input concerning the Tombola at coming meetings.

6. International Restaurant Update – Christina Arvanitaki (Restaurant Coordinator) / restaurant@natocharitybazaar.org Christina introduced herself to the members, stating that she was looking forward to working with them, but that she would not know until the June 25<sup>th</sup> GA meeting, how many nations will be participating in the International Restaurant.

## 7. Sponsorship Update – Dionysia Leolei (Sponsorship) / sponsor@natocharitybazaar.org

Dionysia introduced herself and explained the Sponsor Committee and the Events committee. She informed the members that we have four (4) confirmed sponsors for 2013 – Aramark (Gold), Forax (Silver) and Marriott and Concordia (both Blue). She asked the members to please contact her if they have any fundraising ideas.

# 8. Treasurer Update – Alessandra Foresti (Treasurer) / treasurer@natocharitybazaar.org

Alessandra introduced herself to the new members. She explained that so far we have €2.082 in our account from our first bake sale, but nothing from our sponsors as of yet. She hopes to have more news at the May 28<sup>th</sup> GA meeting.

#### 9. Fundraising Ideas – Jimmie Bradshaw (President) (president@natocharitybazaar.org) & Karen Kiærskou

Jimmie explained that we would like to have more fundraising ideas from our members, and that we also need volunteers to help us with any fundraising initiatives. So please contact Dionysia with any ideas or contributions you might have.

Karen Kiærskou (NR of Denmark) proposed an "Outdoor-Activities" fundraising, where each of us as well as our friends, family and countrymen create a small "piggy bank" in which we deposit a small amount (0,50€or even 0,20€) every time we or members of our family leave the house for the purpose of exercising – whether it be for a walk/jog/run in the forest, bike riding, soccer practice, tennis, swimming, dancing, yoga or even walking the dog.
